Each party shall send a copy of the medical bill and/or the insurance explanation of benefit form and/or proof of payment of the unreimbursed medical expense to the other party by certified mail, return receipt requested, within thirty (30) days of receipt of said document. Whichever party owes reimbursement to the other party shall mail payment to the other party within thirty (30) days of the owing party having received or being in possession of due proof of the unreimbursed amount owed.

- That mother/father shall be granted the tax dependency exemption as follows: _____

If the non-domiciliary parent is granted the tax dependency exemption, then she/he not owe any child support arrearages as of December 31st of that tax year. The domiciliary/custodial parent is ordered to sign all necessary documents to facilitate this order.
